Happy Holidays & Good-Bye to 2017

As the holiday season is upon us, and the year 2017 comes to a close, we look back on all that has happened or taken place in the last year.

While some of the things that have happened may be good things, others may not have been so good.

The bad things that took place in Iowa that will affect some of our members were the changes made by Republicans in the Iowa legislature to Workers Compensation and the public sector collective bargaining laws.

Local 204 represents six public sector bargaining units that have, or will be affected by the changes in the public sector collective bargaining laws. Of these six bargaining units, two of them are classified as "public safety" bargaining units while the others are not. Although there were changes made that negatively affect all of them equally, the four bargaining units that are not considered "public safety" can only negotiate over base wages and nothing else. The "public safety" bargaining units are still allowed to negotiate over most of the issues that they have in the past. Three of these "non-public safety" bargaining units have contracts that will expire in 2018.

Another negative issue that Local 204 has had to deal with because of these changes in the public sector collective bargaining laws was the requirement to have a "recertification election" of these bargaining units months before the expiration of their Labor Agreements. The Union has to pay for the cost of these elections. Two of these "recertification elections" have been held in the past year to see if the members of these bargaining units still want to be represented by Local 204. Local 204 has won both of these elections with the City of Lake Mills and the Scott County Bailiffs, and will start negotiations in 2018. If the results of these elections were not in favor of the Union, the members' Labor Agreement, although not yet expired, would immediately become null and void. There will be more "recertification elections" for these public sector bargaining units in 2018 and subsequent years.

Of some of the good things that happened this past year were the ratification of negotiated Labor Agreements by the members of Local 204. These ratified Agreements were with the following companies.

- Central Iowa Power Cooperative (CIPCO)
- Windstream Communications
- Alliant Energy/IP&L (formerly IES)

2017 Inter-Union Gas Conference

In September of this year, I was given the opportunity to go to the Inter-Union Gas Conference in Portland, Oregon. For someone relatively new to being a Union member, it was a great experience.

Over 350 delegates from different locals and International Unions from all over the United States and Canada gathered Monday the 18th for the conference opening. Donnie Colston (Director, IBEW Utility Department) and Kenneth Cooper (International Secretary-Treasurer) gave opening statements and discussed the IBEW and its partners and the importance of being organized and working together. Together they welcomed a Gas Worker from BG&E (Baltimore Gas & Electric) to share his story of how he and other employees of BG&E reached out to the IBEW to help them and more than 1,400 other workers become organized and members of the IBEW.

In the following days, we broke out into workshops respective of our fields along with different speakers in the afternoons. A lot of topics were covered along with concerns, questions and general discussion. Problems with contractors, inspectors, operator qualifications and adapting to a younger workforce were some of issues talked about.

One of the speakers that week was retired Certified Police Trainer Jim Warwick of the Delaware State Police on situational awareness. This year two Gas Workers were shot and killed in St. Louis by an irate customer who came to their jobsite and ambushed them. Jim talked about the importance of being situationally aware on the jobsite, whether it be in a truck or out doing work. Looking for things or signs that something isn't right. Paying attention to people and their body language is important also. When working in a bad area or dealing with an irate customer have a local law enforcement member escort you.

This was a busy week with a lot of information and conversations. I met people from California, Maryland, Tennessee, Arizona and Canada. All great people. My takeaways from this conference are showing pride in your work, and taking care of our system is taking care of our fellow workers.

International Dues Increase

In September of 2016, the delegates of the 39th IBEW International Convention in St. Louis, Missouri, approved several amendments to Article IX of the IBEW Constitution. As a result of these amendments there will be an increase in the per capita dues for all "A" and "BA" members of the IBEW, effective January 1, 2018. This increase will be an increase from \$18.00 to \$19.00 per month. Therefore, the total monthly International portion of an "A" member's dues will go from \$36.00 to \$37.00, and a "BA" member's dues will go from \$18.00 to \$19.00.

For 2018, there is no increase in the IBEW Pension Benefit Fund (PBF) contributions that only "A" members pay. Also, there is no increase in the local union portion of an IBEW Local 204 member's monthly dues for either an "A" or "BA" member.
