#### **LOCAL 204 OFFICER ELECTION NOTICE**

The election process will begin with nominations of Officers at the April Union Meetings this year. The offices up for election are:

- President
- Vice President
- Recording Secretary
- Treasurer
- Business Manager/Financial Secretary
- Executive Board (Areas/Units 1-9 and 1 At-Large)

Complete information on nomination, elections and qualifications are found in the Local Union Bylaws and the International Union Constitution. If you do not have copies of these documents, they may be obtained by writing to IBEW Local Union 204, 4837 1st Ave. SE, Suite 203, Cedar Rapids, Iowa 52402.

#### **NOMINATIONS**

To qualify as a nominee for office, a member must have at least two (2) years' continuous good standing in the Local Union immediately prior to April 1, 2018. (IBEW Constitution, Article XVI, Section 10.) Nominations for Local Union offices shall be held at the regular meetings of each Area/Unit in April of election years. (Local Union Bylaws).

No member shall be a candidate for more than one office, except as provided in the Bylaws and with International approval. If nominated for more than one office, he/she shall immediately declare for which office he/she will be a candidate. However, this shall not apply to offices which have been combined with the approval of the International President (Local Union Bylaws).

Members in one Area/Unit may nominate members of another Area/Unit for Local Union office. It is not necessary that such nominees be confined to a particular Area/Unit. A member placing the name of another member in nomination for office when the nominated member is not present, shall at the time the nomination is made, give evidence in writing, signed by the nominee, that the nominee agrees to be a candidate for a specific Local Union office. However, any member nominated in this manner cannot signify his/her intention to be a candidate for more than one specific Local Union office (Local Union Bylaws).

There will be one (1) at-large Executive Board position.

The ballots will be mailed on May 10, 2018, and must be in the Local 204 post office box #9035 in Cedar Rapids on June 12, 2018, at 9:00 am. The ballots will be picked up at the post office box on June 12, 2018, at 9:00 am by the Judge and Tellers and counted thereafter.

#### Turn in your Near Miss or Lesson Learned

"It could have been much worse", or "I'll never let that happen again". How often do we hear those phrases being said? Probably more than we realize. These comments are usually made when something unexpected happened in the workplace, where there could have been extensive property damage, an injury to you, a fellow employee or the public. Or worse yet, death. Every time we use either one of these phrases, it's probably an opportunity for a Near Miss or a Lesson Learned.

Has this happened to you lately? Have you shared it with other employees so that they can learn from it? Did you know that you can turn it in anonymously to your Alliant Energy Safety Blue Hat without fear of repercussions? If it's something that your Supervisor needs to be aware of, discuss it with him/her and tell them you want to work with a Blue Hat to share it in a Weekly Safety Packet.

If nothing was damaged, you can go directly to your Blue Hat and it will be taken care of. As mentioned earlier, it will be totally anonymous. We'll listen to your description of what happened and write it up. We'll send it back to you for approval before it ever goes in a Weekly Safety Packet.

If you decide that you don't want to send it in after it gets written up, the process will stop. Just for the record, no one has been disciplined for turning in a Near Miss or Lesson Learned.

What do you have to lose by turning in a Near Miss or Lesson Learned? Absolutely nothing, but you may prevent someone else from dealing with the same issue. Give us a call and we'll help out in any way we can.
