First of all I want to thank everyone who voted on the rerun of the Business Manager election. The numbers were up and shows that members are ready and wanting to get more involved. Now that we have the elections behind us and are full staffed here in the hall we can look forward and tackle the many issues we face. The IPC negotiations are upon us and we stand ready to go to the table and fight for what we have left and what we believe in. We also have the AMU contract expiring at the end of the year, so those negotiations will be coming up as well. We have two recertification elections taking place this fall with the Lake Mills Municipal contract and Scott County. On top of that we are still trying to gain some traction with NextEra and gather some information regarding the future of DAEC. Jon Van Zante and I had a meeting out at DAEC with the NextEra reps and a couple stewards the beginning of September, but at this time they just don't know what the plan is moving forward to decommissioning. That doesn't mean they won't have a plan, it just means they are working on a plan. NextEra did agree to start more regular meetings in October to try and hammer out some decommissioning language.

There are a few things that we are looking to change or tweak. One thing we have heard from the membership and which has become a priority for all of us is better communication. We believe we can better utilize technology and our resources to get information out to the membership in a more timely and effective manner. One thing we are working on is getting our website up to date and trying to figure out what we can do with the website to make it more user friendly. We want the website to be a place our members can go to and find out what's going on at the hall, check calendars, look at pictures, order apparel and hats, send a message, look up contact information, etc. We want to tie the Facebook page into the website and we want to have a place where our members can submit their contact information to receive mass texts or emails. We are currently working with a web design professional who is updating our website and will be adding features as we go. We think this will be well utilized and a great tool for commination.

As we talk about trying to better communicate information out to the members, I want to take this time to ask a question. Is your contact information up to date at the hall? We would like to work on updating steward's lists and make sure we have up to date and correct email and phone numbers for all members.
