Fortunately, we also had a variety or diverse portfolio of electric generation to make this happen. A large shout out to the folks working the Coal, Gas

and Wind Turbines for their hard work during these times! Far too often we see in the news and on TV commercials all the negative press the fossil fuels receive. The irony is, without these fossil fuels the world comes to a halt. Look at the chaos and turmoil that happened down in Texas due to some bad decision making, all of it unnecessary. The good folks at MISO along with utility companies in their territories worked and performed flawlessly to assure that us in the Midwest had the power we needed.

#### **2021 Officer & Executive Board Elections**

The election of Officers and E-Board takes place this year. The IBEW's Constitution, Article XVI and the By-Laws of IBEW, Local 204, Article III, govern our election. Our E-Board has approved doing nominations by mail this year. You may self-nominate yourself and mail a letter to the local union accepting the nomination. A sample letter is below. Nominations will begin on April 1, 2021 and conclude on April 30, 2021. May 5, 2021 will be a scheduled Cedar Rapids union meeting. This meeting will be open to the members (there may be limited members allowed into the meeting depending on the restrictions) and all nominations received will be read at this meeting. Once a candidates eligibility to run for office has been verified, they will be contacted by the election judge.

Nominations will proceed in the order of offices as listed in the IBEW Constitution whose term of office shall be three (3) years:

President

Vice President

**Recording Secretary** 

Financial Secretary/Business Manager

Treasurer

Executive Board (Central, DAEC, Eastern, North Central, Northeast, Northwest, South Central, Southeast, Southwest, and one At-Large)

Additionally, nominations will be held for delegates to the International Convention which will be held this summer.
